LETTER FROM CEO & BOARD CHAIR

We have done something amazing together!

In the last year, Montgomery County reduced the number of people experiencing homelessness by 23%. Since 2015, there has been even greater impact—a 41% reduction in the number of people experiencing homelessness.

For nearly 30 years MCCH has worked to end the experience of homelessness for our vulnerable neighbors. MCCH played a robust role in ending veteran homelessness in 2015, in ending chronic homelessness in 2019, and we look forward to working with the county and our nonprofit partners to continue ending homelessness for everyone in our county.

The support of our community partners and compassionate neighbors has been essential to our success and will continue to help MCCH maintain this level of momentum in pursuit of our mission to make homelessness a rare, brief, and one-time only experience.

This support was especially needed this year as MCCH faced an unexpected challenge. Our administrative offices and our men's emergency shelter were located on the same campus as a county-owned methane plant, where mechanical issues resulted in the emergency evacuation of our administrative office in February 2019 and the men's shelter in May 2019. We continue to work closely with the county to develop long-term solutions for a permanent location for our men's shelter.

We are incredibly proud of our 150 staff members who have continued to work tirelessly during this uncertain time. They have enabled our clients to move forward in their lives and take steps towards building brighter futures.

On behalf of the Board of Directors, MCCH staff, and most importantly the 1,600 men, women, and children we served this year, thank you for helping us create a community in which everyone has a safe, stable, and affordable place to call home.



Our Programs

In FY19 MCCH served 1,676 men, women, and children in Montgomery County through our emergency shelter and permanent supportive housing programs.


MCCH provides 60% of the County's emergency shelter beds through two emergency programs, which provided shelter and services to meet the needs of over 700 individuals currently experiencing homelessness. Our ten permanent supportive housing programs helped 910 adults and children maintain their housing stability by combining permanent, affordable housing and supportive services.

OUR IMPACT

EMERGENCY SHELTER PROGRAMS

We served 720 men in our HBCAC Men's Emergency Shelter and 46 veterans in our VA Safe Havens programs in FY19. Both programs provide shelter, food and supportive services to help clients exit homelessness and return to stable housing as quickly as possible.

OUR IMPACT

PERMANENT SUPPORTING HOUSING PROGRAMS

MCCH's ten permanent supportive housing programs combine ongoing case management and supportive services with affordable housing through deep rental subsidies to help formerly homeless families and individuals maintain housing stability. In FY19, our permanent supportive housing programs served 910 individuals including 162 families and 300 children.




OF PSH HOUSEHOLDS MAINTAINED THEIR HOUSING STABILITY AS A RESULT OF MCCH'S SUPPORT.
