# LETTER FROM CEO & BOARD CHAIR

The dedication and undying commitment of MCCH's staff, Board and network of community supporters has shown this year as we faced unprecedented challenges in our efforts to ensure that homelessness is rare brief and a one-time experience for our Montgomery County neighbors. We kept a laser eye on ensuring that our essential emergency shelter services for men in our community did not skip a beat when we had to evacuate our shelter and move to a temporary location. And then a few months later with the COVID-19 pandemic at our door, we rose to the occasion to safeguard the health and safety of our staff and clients as we sustained our important work.

In the face of a global pandemic, we quickly realized that our work had become even more vital as people began to lose their jobs and their homes because of COVID-19. With the support of our community, our clients and dedicated staff were able to face the challenges of this pandemic in several key ways.

We were able to safeguard the health of 200 men experiencing homelessness. This required expanding the men's emergency shelter from one location to three, hiring additional staff, and providing acute crisis pay. We also placed the most vulnerable men in a hotel to protect their health.

To ensure the safety of our clients in our housing programs, we created a special team to serve those in crisis. These MCCH staff members went out into the community during the height of the pandemic to address the food security, mental health, and safety of 520 permanent housing households. We are incredibly proud of this team, our shelter team, and the rest of our 150 staff members for their unwavering dedication during this challenging year.

While some of our clients and staff have tested positive for COVID-19, the exposure rate has been very low, around 2%. And we are proud to share that during the pandemic, we've helped 20 people end their homelessness and move into the safety of their own homes!

On behalf of the Board of Directors, MCCH staff, and most importantly the 1,600 children, parents, veterans, and individuals we served this year, thank you for your vital support helping us create a community in which everyone has a safe, stable, and affordable place to call home.

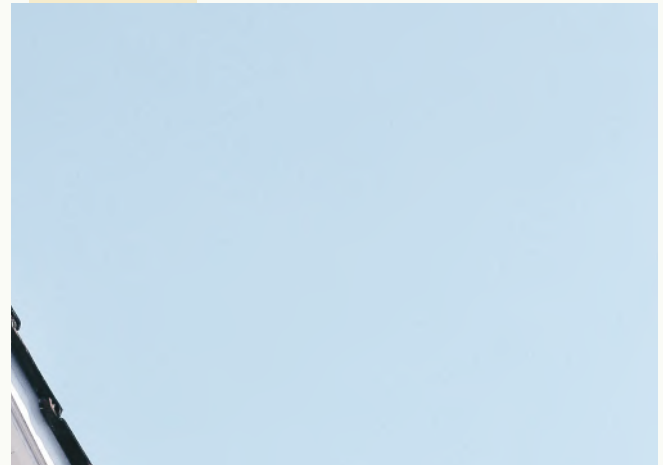

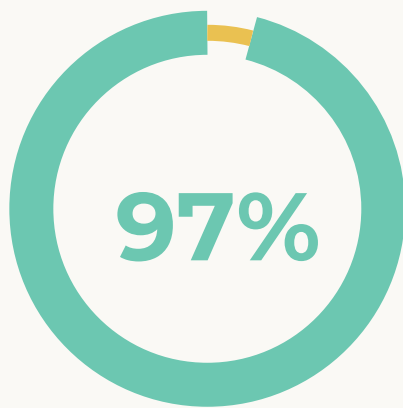
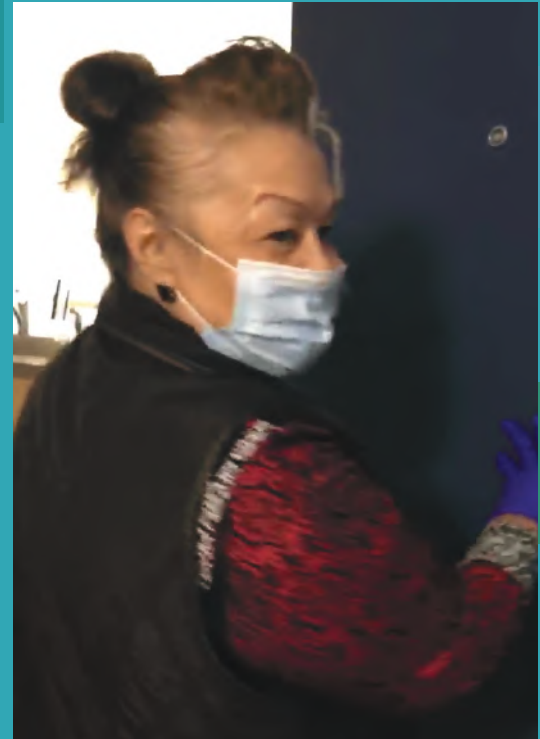
We served **664 men** in our HBCAC Men's Emergency Shelter and **63 veterans** in our VA Safe Havens programs in FY20. Both programs provide shelter, food, and supportive services to help clients exit homelessness and return to stable housing as quickly as possible.

MCCH helped Corey end his homelessness after living in the woods in Clarksburg for the past two years with significant mental health issues. Our shelter staff worked diligently and found an appropriate home for both Corey and his service animal, Atticus. Not only does Corey now have a safe and stable home during this health crisis, MCCH will make sure he has the support of case management and ongoing rent support so he does not return to homelessness.

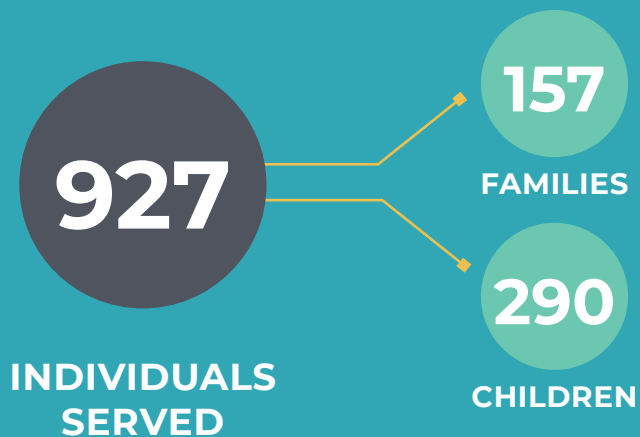

MCCH's ten permanent supportive housing programs combine ongoing case management and supportive services with affordable housing through deep rental subsidies to help formerly homeless families and individuals maintain housing stability. In FY20, our permanent supportive housing programs served **927 individuals, including 157 families and 290 children**

On the day that she walked into her apartment for the first time, she could hardly contain her excitement! 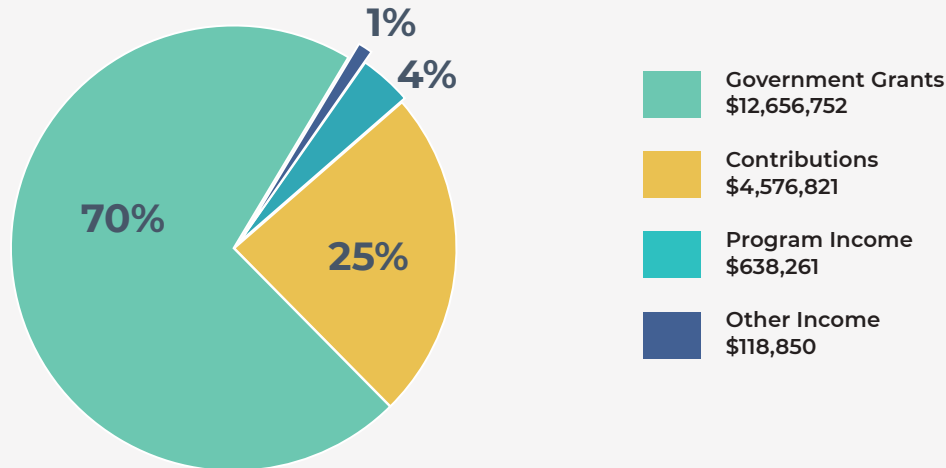
